

## Privacy Policy

This privacy policy has been compiled to better serve those who are concerned with how their 'Personally Identifiable Information' (PII) is being used online. PII, as described in US and EU privacy law and information security, is information that can be used on its own or with other information to identify, contact, or locate a single person, or to identify an individual in context. Please read our privacy policy carefully to get a clear understanding of how we collect, use, protect or otherwise handle your Personally Identifiable Information in accordance with our website.

### **What personal information do we collect from the people that visit our blog, website or app?**

We use regular Malware Scanning.

Your personal information is contained behind secured networks and is only accessible by a limited number of persons who have special access rights to such systems, and are required to keep the information confidential. In addition, all sensitive/credit information you supply is encrypted via Secure Socket Layer (SSL) technology.

We implement a variety of security measures when a user places an order enters, submits, or accesses their information to maintain the safety of your personal information.

All transactions are processed through a gateway provider and are not stored or processed on our servers.

### **Do we use 'cookies'?**

Yes. Cookies are small files that a site or its service provider transfers to your computer's hard drive through your Web browser (if you allow) that enables the site's or service provider's systems to recognize your browser and capture and remember certain information. For instance, we use cookies to help us remember and process the items in your shopping cart. They are also used to help us understand your preferences based on previous or current site activity, which enables us to provide you with improved services. We also use cookies to help us compile aggregate data about site traffic and site interaction so that we can offer better site experiences and tools in the future.

### **We use cookies to:**

- Help remember and process the items in the shopping cart.
- Compile aggregate data about site traffic and site interactions in order to offer better site experiences and tools in the future. We may also use trusted third-party services that track this information on our behalf.

You can choose to have your computer warn you each time a cookie is being sent, or you can choose to turn off all cookies. You do this through your browser settings. Since browser is a little different, look at your browser's Help Menu to learn the correct way to modify your cookies.

We will notify you via email

We also agree to the Individual Redress Principle which requires that individuals have the right to legally pursue enforceable rights against data collectors and processors who fail to adhere to the law. This principle requires not only that individuals have enforceable rights against data users, but also that individuals have recourse to courts or government agencies to investigate and/or prosecute non-compliance by data processors.

### **CAN SPAM Act**

The CAN-SPAM Act is a law that sets the rules for commercial email, establishes requirements for commercial messages, gives recipients the right to have emails stopped from being sent to them, and spells out tough penalties for violations.

# Registration

- If LABUDHI MEDITATION finds, for whatever reason, you are unfit to attend a course we reserve the right to deny you enrollment  
In this case, any amount paid by the applicant as booking/registration fee will be refunded in full
- In case due to some emergency a student is not able to come on time, he/she must inform LABUDHI MEDITATION in advance and he/she may be admitted to training/workshop/retreat at the discretion of LABUDHI MEDITATION
- LABUDHI MEDITATION requires that all trainees attending our courses have comprehensive travel and medical insurance for the duration of their training/workshop/retreat
- Late registration depends on the availability of seats
- Trainee identification such as a photocopy of Passport and Visa must be provided during the check in at the school before start the program
- LABUDHI MEDITATION cannot guarantee your booking for retreats/workshops until the full payment of the package is made

# Cancellation Policy

- In case the applicant decides to cancel his/her registration at any time before the commencement of a course then LABUDHI MEDITATION will refund the amount paid as booking/registration fee as follows: - before 90 days: 80% will be refunded - before 60 days: 40% will be refunded - within 60 days: NO refund
- LABUDHI MEDITATION has a strict NO REFUND Policy in case a student withdraws from retreat courses after the training commences under any circumstance  
Also, if a training/ workshop/retreat must be abandoned or interrupted due to exceptional circumstances there will not be a refund if more than half of the training has been completed (start and finish dates inclusive)  
However, a student can transfer his/her fees towards any future date within one year of original registration date  
Also, we only allow students to postpone their dates ONCE after which their application will be cancelled
- In the unlikely event that LABUDHI MEDITATION retreat is canceled 100% of the payment will be refunded, or an alternative retreat or training placement will be offered according to the circumstances
- LABUDHI MEDITATION accepts no responsibility for flight costs in the event of cancellation of retreats

Stage Three: We will reply our response to your complaint after discussing with our management team and staff. If it is not possible to provide a full answer within 3 days after Stage 2, we will provide a letter outlining the reasons why and give a date by which a full answer is expected

There will be no refunds given under any circumstance unless decided by LABUDHI MEDITATION Management Team
